Dispatch Services Agreement (Optional)

Dispatch Fee: 10% of gross load revenue. Payment Terms: Net 30 from load settlement; factoring typically allows payment advance within 24–72 hours of submitting signed BOL and rate confirmation. Responsibilities: Carrier is responsible for compliance, licensing, and maintenance. FMSL provides load matching, rate negotiation, and dispatch support. Termination: Either party may terminate with 30 days' written notice.

Lease-On Agreement (Optional)

Lease-On Fee: 5% of gross load revenue. Owner-operators must carry their own insurance unless enrolled in the FMSL group policy. Fee: \$0.10 per mile if FMSL insurance is provided. Fuel Advances: Optional; 3% processing fee applies. Payment Terms: Net 30; factoring may provide advance within 24–72 hours. Responsibilities: Carrier maintains compliance with DOT and FMCSA regulations. FMSL provides dispatch support, optional fuel advances, and administrative assistance. Termination: Either party may terminate with 30 days' written notice.
